SIGNING OF THE LETTER OF EXCHANGE BETWEEN MALAYSIA AND THE US FOR THE IMPLEMENTATION OF APEC TEL MRA

Malaysia and the United States have formally concluded negotiations regarding certification of locally made radio frequency equipment exported to the United States, through the signing of the letters of exchange on 28 June 2016 by the Ministry of International Trade and Industry and the Office of the United States Trade Representative (USTR) on the adoption and implementation of the APEC TEL MRA.

Malaysia is the third country in ASEAN, after Singapore and Viet Nam, to adopt the Conformity Assessment of Telecommunication Equipment, Phase 1 (APEC TEL MRA), International Trade and Industry Minister YB Dato' Sri Mustapa Mohamed said.

"The conclusion of these negotiations is vital to facilitate exports of Malaysia's telecommunications equipment to the United States market. The Government is committed to ensure that exports of our radio frequency equipment to the US, valued at RM11.4 million in 2015 and accounted for 22.7% or RM41.1 billion of global exports in the same year, are not disrupted by the new ruling in the US," YB Dato' Sri Mustapa said.


This initiative is pursuant to a new ruling introduced by the United States Federal Communications Commission (US FCC) whereby labs and telecommunication-certified bodies outside the United States must be accredited and designated by the USFCC under the terms of an MRA. The ruling came into force on July 13, 2015, with an original one-year grace period until 13 July 2016. However, on 21 June 2016, the United States decided to extend the grace period by another year to 13 July 2017 to give industries more time to adjust and to avoid any potential disruption of the distribution and sale of radio frequency equipment.

YB Dato' Sri Mustapa urged local labs that are currently listed with the US FCC to contact MCMC and Standards Malaysia to apply for the Accreditation Process for Testing Laboratory under the MRA.


Malaysia Manufacturing Performance, May 2016

KERAJAAN KOMITED UNTUK MEMASTIKAN AGAR DASAR-DASAR UTAMA NEGARA TERMASUK KESUCIAN AGAMA ISLAM DAN HAK BUMIPUTERA TERPELIHARA.

Kedudukan Islam sebagai Agama Persekutuan terkandung dalam Perkara Tiga Perlembagaan Persekutuan dan ianya akan kekal terpelihara. Kerajaan tidak akan sama sekali membenarkan sebarang FTA menjejaskan perkara ini.

Terdapat kebimbangan penyertaan Malaysia ke dalam TPPA akan menggugat peraturan-peraturan berlandaskan Agama Islam. Antara dakwaan tersebut ialah Kerajaan akan disaman oleh pelabur-pelabur asing jika melaksanakan peraturan-peraturan seperti;

- (i) Pengasingan produk halal dan haram.
- Larangan kunjungan umat Islam ke premis perniagaan yang menjalankan aktiviti yang haram untuk mereka.
- (iii) Cuti umum pada hari Jumaat
- (iv) Peraturan larangan sesetengah bentuk perniagaan pada waktu-waktu dan bulan tertentu.

Sebenarnya tidak ada asas kepada kebimbangan ini. TPPA tidak akan menghalang Malaysia daripada terus menguatkuasakan syarat-syarat halal ke atas pengimportan produk makanan. Syarat halal telah diiktiraf sebagai bukan satu bentuk halangan

- 30 peratus daripada nilai kontrak kerja yang dibuka untuk penyertaan kontraktor dari negara-negara ahli TPPA dikhaskan untuk kontraktor Bumiputera.
- Keutamaan harga kepada pembekal dan pembuat Bumiputera dalam perolehan bekalan dan perkhidmatan dikekalkan.
- (iii) Had nilai perolehan dan tempoh peralihan yang panjang bagi perolehan kerajaan. Ini bermakna perolehan bekalan, perkhidmatan dan perkhidmatan pembinaan di bawah had nilai perolehan yang ditetapkan boleh dihadkan kepada syarikat tempatan sahaja.

Dalam sektor pasar raya *hyper (hypermarket)*, syarat pegangan ekuiti Bumiputera sebanyak 30 peratus; pemasaran dan jualan, 30 peratus produk Bumiputera atas rak dan lantikan pengarah Bumiputera masih dikekalkan seperti mana dasar yang sedia ada.

Bagi sektor minyak dan gas pula, PETRONAS boleh memberikan keutamaan bagi sekurang-kurang 40 peratus daripada jumlah nilai peruntukan perbelanjaan tahunan bagi perolehan kepada pembekal Bumiputera, PKS, Sabah dan Sarawak.

Perolehan kerajaan yang dilaksanakan oleh pihak-pihak berikut pula dikecualikan daripada obligasi perolehan kerajaan di bawah TPPA:

ISU BERHUBUNG PENYERTAAN BUMIPUTERA DI DALAM SEKTOR EKONOMI TURUT MENIMBULKAN KEBIMBANGAN KERANA TPPA AKAN MEMBUKA PELUANG KEPADA PELABUR ASING MENYERTAI PEROLEHAN KERAJAAN.

Berhubung dengan agenda pembangunan Bumiputera, bagi menjamin penyertaan Bumiputera di dalam sektor ekonomi tidak terjejas, Malaysia telah berjaya merundingkan kelonggaran dan pengecualian dalam beberapa bab melalui pelbagai mekanisme.

Bagi perolehan kerajaan, kelonggaran dan pengecualian seperti berikut telah diberikan,

- (i) Beberapa agensi Persekutuan.
- (ii) Kesemua Kerajaan Negeri dan Pihak Berkuasa Tempatan.
- (iii) Hampir semua badan berkanun (kecuali empat yang terletak di bawah MITI).
- (iv) Kesemua Syarikat Hak Milik Kerajaan.

Bagi membantu usahawan Bumiputera termasuk PKS untuk terus bersaing, Kerajaan menyediakan pelbagai bantuan serta latihan untuk meningkatkan keupayaan serta daya saing PKS. Antara program tersebut ialah:

- (i) Pinjaman softloan MIDF, SME Bank.
- (ii) Program Peningkatan Kemahiran oleh SMECorp, INSKEN.
- SCORE Rating SME Competitive Rating for Enhancement untuk penilaian kualiti produk tempatan ke pasaran luar.
- (iv) Program Mentor IKS oleh SME Corp.







Malaysia's Trade with Singapore, 2005 - 2015



















Malaysian Ringgit Exchange Rate with Euro and Singapore Dollar







Average Domestic Prices. 15 July 2












Commodity Price Trends









AUO SunPower Sdn. Bhd. is a joint venture between Sunpower Corporation, a Silicon Valley based manufacturer of high-efficiency solar cells, solar panels and solar systems and AUO, a Taiwan-based entity. AUO Sunpower designs, manufactures and delivers the most powerful solar cells in the world, providing green, renewable energy solutions in virtually every sector of the economy, worldwide. Its export market comprises of USA, Europe and Asia, where some of the highest solar panel users in the world are based. This project will create about 4,000 high technology manufacturing and engineering jobs as well as support the future growth of small and medium industries and businesses within the supply chain of this sector.

Based in Melaka and with an investment of RM2.2 billion, AUO SunPower is expected to generate more than 1,400 megawatts annually of high-efficiency solar cells when completed in 2013. Its plant in Alor Gajah has been in operation since October 2010 with a 60 percent capacity and will produce 400 million high-efficiency solar cells annually on full capacity. Recognised by the International Energy Agency for its energy efficient design, it is one of the biggest and greenest factories in the world. This facility is a component of an EPP within the Electronics & Electrical NKEA to grow solar wafer and cell producers in Malaysia as part of the ETP.

IMPLEMENTATION OF THE EXPANSION OF THE INFORMATION TECHNOLOGY AGREEMENT (ITA2)

Malaysia has completed all its domestic processes on the reduction and elimination of tariffs on a total of 201 high-technology ICT products in line with the Information Technology Agreement (ITA2) concluded at the 10th World Trade Organisation Ministerial Conference (MC10) on 17 December 2015. The new rules came into effect on July 1, 2016.

The 201 high technology ICT products include new generation multicomponent integrated circuits (MCOs), touch screens, GPS navigation equipment, portable interactive electronic education devices, video game consoles, and medical equipment, such as magnetic resonance imaging products and ultra sonic scanning apparatus.

Malaysia's commitment for the 201 products covers 410 affected tariff lines (9 digit). Of the 410 lines, 351 lines (86%) are already at zero duty (nil import duty). The remaining 59 tariff lines have current applied duties ranging from 5% to 30% which will be progressively removed.

A total of 24 WTO members, including Malaysia, participated in ITA2. Other members include major IT producing counties and regions such as China, the United States, the European Union, Japan, South Korea and Singapore and Thailand from ASEAN. All 24 Members have agreed and are committed towards eliminating the WTO bound rates for 201 products, based on the agreed staging periods namely, immediate elimination, 3-year staging, 5-year staging and 7-year staging.

Malaysia's Involvement in the earlier ITA1 had helped the country's ICT industry increase exports nearly three-fold from USD21.7 billion in 1996 to USD60.5 billion in 2010, averaging 8% annual growth. Malaysia was ranked 8th out of 30 leading exporters and 9th out of 30 leading importers of ICT products in 2010. With this further liberalisation under ITA2, Malaysia's ICT industry will have easier access to a wider market globally for its products.

The ITA Expansion commitments will provide market opportunities for more than 600 local producers to boost their exports to participating countries. Malaysian producers of ICT products will also benefit from the lowering of production costs in terms of the import of cheaper parts and components, thereby improving the competitiveness of Malaysia's exports.


