PERINTAH KASTAM (DUTI ANTI-LAMBAKAN) (NO. 3) 2020 (PINDAAN) 2025

PADA menjalankan kuasa yang diberikan oleh seksyen 25 Akta Duti Timbal Balas dan Anti-Lambakan 1993 [*Akta 504*] dan subseksyen 11(1) Akta Kastam 1967 [*Akta 235*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Kastam (Duti Anti-Lambakan) (No. 3) 2020 (Pindaan) 2025**.

(2) Perintah ini berkuat kuasa bagi tempoh mulai 13 Februari 2025 hingga 11 Disember 2025.

2. Perintah Kastam (Duti Anti-Lambakan) (No. 3) 2020 [*P.U. (A) 348/2020*] dipinda dalam Jadual, berhubung dengan Republik Sosialis Viet Nam—

(a) dalam ruang (4), dengan menggantikan perkataan “Hoa Phat Steel Sheet Company” dengan perkataan “Hoa Phat Steel Sheet Limited Liability Company”; dan

(b) dalam ruang (5), dengan menggantikan perkataan “3.06%” dengan perkataan “4.89%”.

COUNTERVAILING AND ANTI-DUMPING DUTIES ACT 1993 AND CUSTOMS ACT 1967
CUSTOMS (ANTI-DUMPING DUTIES) (NO. 3) ORDER 2020 (AMENDMENT) ORDER 2025

IN exercise of the powers conferred by section 25 of the Countervailing and Anti-Dumping Duties Act 1993 [*Act 504*] and subsection 11(1) of the Customs Act 1967 [*Act 235*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs (Anti-Dumping Duties) (No. 3) Order 2020 (Amendment) Order 2025**.

(2) This Order has effect for the period from 13 February 2025 to 11 December 2025.

Amendment of Schedule

2. The Customs (Anti-Dumping Duties) (No. 3) Order 2020 [*P.U. (A) 348/2020*] is amended in the Schedule, in relation to The Socialist Republic of Viet Nam—

(a) in column (4), by substituting for the words “Hoa Phat Steel Sheet Company” the words “Hoa Phat Steel Sheet Limited Liability Company”; and

(b) in column (5), by substituting for the words “3.06%” the words “4.89%”.
