GUIDELINES FOR IMPORT LICENSE (AP) PRIVATE VEHICLES FOR MALAYSIA MY SECOND HOME (MM2H) PROGRAMME

A. CURRENT POLICY

Applicants have approval under the My Second Home programme in the Immigration Department of Malaysia / Ministry of Tourism, Arts and Culture.

B. QUALIFYING CONDITIONS

Imported vehicles either new/used must be registered in the name of the applicant in the home country/at least **6 months** from the date of approval of the visa MM2H.

C. APPROVAL REQUIREMENT

- 1. Vehicle must be registered in the name of the applicant;
- 2. The vehicle shall not be sold/exchanged in the first 2 years after registration in Malaysia;
- 3. The vehicle is not exchangeable/sold to another party without paying all duties/taxes which have been exempted in accordance with the Royal Malaysian Customs Office assessment; and
- 4. Importation of vehicles must be enclosed with a copy of Certificate of Registration.

FOR VISA MALAYSIA MY SECOND HOME (MM2H) PROGRAMME APPROVED ON 1 JANUARY 2017 TO 31 DECEMBER 2017

D. CURRENT POLICY

Applicants have approval under the My Second Home programme in the Immigration Department of Malaysia / Ministry of Tourism, Arts and Culture.

E. QUALIFYING CONDITIONS

Imported vehicles must be registered in the name of the applicant in the original country/domicile at least **3 years** from the approval date of the visa MM2H.

F. APPROVAL REQUIREMENT

- 1. Vehicle must be registered in the name of the applicant;
- 2. The vehicle shall not be sold/exchanged in the first 5 years after registration in Malaysia;

GP MM2H

- 3. The vehicle is not exchangeable/sold to another party without paying all duties/taxes which have been exempted in accordance with the Royal Malaysian Customs Office assessment; and
- 4. Importation of vehicles must be enclosed with a copy of Certificate of Registration.

G. APPLICATION PROCEDURE

- 5. Each application must be submitted via http://reg.dagangnet.com/ to include organized and complete forms and supporting documents as follows:
 - (i) Private vehicle Import License Application Form; and
 - (ii) Copies of the supporting documents specified in the checklist
- 6. Fraud of documents/information to any government body is a serious and unlawful offence. In the event that MITI finds a document/information in the application submitted or approval has been given, MITI reserves the right to reject the application or cancel such approval. Further, the applicant may also be blacklist and subject to legal action for such offences.
- 7. Decision on application for personal vehicle will be made within 5 working days.
