



## INITIATION OF AN ADMINISTRATIVE REVIEW ON THE ANTI-DUMPING DUTIES ON IMPORTS OF FLAT ROLLED PRODUCTS OF NON-ALLOY STEEL COATED OR PLATED WITH ALUMINIUM AND ZINC (GALVALUME) ORIGINATING OR EXPORTED FROM HOA PHAT STEEL SHEET LIMITED LIABILITY COMPANY IN THE SOCIALIST REPUBLIC OF VIET NAM

On 17 July 2024, the Government of Malaysia (Government) had received an application from a foreign exporter, namely Hoa Phat Steel Sheet Limited Liability Company (the Applicant) from the Socialist Republic of Viet Nam (Viet Nam) requesting for an administrative review of the current anti-dumping duty imposed on the imports of flat rolled product of non-alloy steel plated or coated with aluminium and zinc (subject merchandise) originating or exported from the Applicant.

The request is made based on the grounds that the dumping margin of the subject merchandise originating or exported from the Applicant has changed substantially pursuant to paragraph 28(1)(a) of the Countervailing and Anti-Dumping Duties Act 1994 (Act 504) and subregulation 34(1) of the Countervailing and Anti-Dumping Duties Regulations 1994 (Regulations 1994). The original anti-dumping investigation was initiated on 17 March 2020 and the final affirmative anti-dumping duties were imposed on the subject merchandise originating or exported from Viet Nam ranging between 3.06% to 37.14%, effective from 12 December 2020 to 11 December 2025.

With regard to this Application, the Government has evaluated and determined that the information and evidence submitted by the Applicant carry sufficient grounds to initiate an administrative review concerning imports of the subject merchandise originating or exported from the Applicant pursuant to paragraph 28(1)(a) of Act 504 and sub regulation 34(1) of Regulations 1994.

In accordance with Act 504 and Regulations 1994, the Government will initiate the administrative review and the final determination will be made within 180 days from the date of initiation.

The Ministry of Investment, Trade and Industry (MITI) will distribute a set of questionnaires and/or relevant documents to interested parties, such as domestic producers, importers and associations. Other interested parties who wish to participate in the administrative review may request for the questionnaires in writing to MITI no later than 31 August 2024.

Interested parties may also provide their views in writing, questionnaire response and additional supporting evidence to MITI by 15 September 2024. In the event that the interested parties do not provide the necessary information or the information and views are not received in an adequate form within the specified time limit, the Government may make its final determination based on the available facts.
