### 1. YBHG DATO' LOKMAN HAKIM ALI

Y. Bhg. Dato' Lokman Hakim bin Ali is currently the Secretary General of the Ministry of International Trade and Industry. She was involved in the financial sector resolution initiatives during the Asian financial crisis. She was instrumental in the formulation and implementation of the Financial Sector Masterplan (2001-2010) and Financial Sector Blueprint (2011-2020) that charted the development of the Malaysian financial system. As Deputy Governor from 2010 to 2016, she was responsible for banking, insurance and Takaful supervision, financial intelligence and enforcement, talent management, finance and shared services of the Central Bank. She also represented Bank Negara Malaysia in the Basel Committee on Banking Supervision and the Financial Action Task

Force. She graduated from the University of South Australia with a Bachelor of Arts in Accountancy and is a Certified Practising Accountant (CPA).
