## INITIATION OF ADMINISTRATIVE REVIEW OF ANTI-DUMPING DUTIES WITH REGARD TO IMPORTS OF STRANDED STEEL WIRES FOR PRESTRESSING CONCRETE ORIGINATING OR EXPORTED FROM THE PEOPLE'S REPUBLIC OF CHINA

On 9 July 2024, the Government of Malaysia (Government) received an application from a domestic producer, Southern PC Steel Sdn. Bhd. (Applicant), requesting for an administrative review of anti-dumping duties on imports of stranded steel wires for prestressing concrete (subject merchandise) originating or exported from the People's Republic of China (PRC).

The request was made based on the grounds that the dumping margin of the subject merchandise originating or exported from PRC has changed substantially pursuant to paragraph 28(1)(a) of the Countervailing and Anti-Dumping Duties Act 1993 (Act 504) and regulation 34 of the Countervailing and Anti-Dumping Duties Regulations 1994 (Regulation 1994). The original anti-dumping investigation was initiated on 31 March 2021 and the final affirmative anti-dumping duties imposed on the subject merchandise originating or exported from PRC range between 2.09% to 21.72%, effective from 25 December 2021 to 24 December 2026.

With regard to this application, the Government has evaluated and determined that the information and evidence submitted by the Applicant carries sufficient grounds to initiate an administrative review concerning the imports of the subject merchandise originating or exported from PRC pursuant to paragraph 28(1)(a) of Act 504 and sub regulation 34(1) of Regulations 1994.

In accordance with Act 504 and Regulations 1994, the Government will initiate the administrative review and the final determination will be made within 180 days from the date of initiation.

The Ministry of Investment, Trade and Industry (MITI) will distribute a set of questionnaires and/or relevant documents to interested parties such as domestic producers, Silvery Dragon Prestressed Materials Co., Ltd. Tianjin dan Tianjin Dalu Steel Strand For Prestressed Co., Ltd., importers and associations as well as the Government of China. Other interested parties who wish to participate in the administrative review may request for the questionnaires in writing to MITI no later than 23 August 2024. Interested parties may also provide their views in writing, questionnaire responses and additional supporting evidence to MITI by 7 September 2024. In the event the interested parties do not provide the necessary information or the information and views are not received in an adequate form within the specified time limit, the Government may make its final determination based on the available facts.
