## **MEDIA RELEASE**

**INITIATION OF ADMINISTRATIVE REVIEW OF AN ANTI-DUMPING DUTY  
WITH REGARD TO THE IMPORTS OF FLAT ROLLED PRODUCT OF NON-  
ALLOY STEEL PLATED OR COATED WITH ALUMINIUM AND ZINC  
ORIGINATING OR EXPORTED FROM TAN PHUOC KHANH TRADING &  
MANUFACTURING COIL STEEL JSC, THE SOCIALIST  
REPUBLIC OF VIET NAM**

On 25 November 2022, the Government of Malaysia (GOM) has received an application from a foreign exporter, namely Tan Phuoc Khanh Trading & Manufacturing Coil Steel JSC (the Applicant) from the Socialist Republic of Viet Nam (Viet Nam) requesting the GOM to initiate an administrative review of the current anti-dumping duty imposed on the imports of flat rolled product of non-alloy steel plated or coated with aluminium and zinc (subject merchandise) originating or exported from the Applicant.

The request is made based on the grounds that the dumping margin of the subject merchandise originating or exported from the Applicant has changed substantially pursuant to paragraph 28(1)(a) of the Countervailing and Anti-Dumping Duties Act 1994 and subregulation 34(1) of the Countervailing and Anti-Dumping Duties Regulations 1994. The original anti-dumping investigation was initiated on 17 March 2020 and the final affirmative anti-dumping duty was imposed on subject merchandise originating or exported from Viet Nam ranging from NIL to 37.14% effective from 12 December 2020 to 11 December 2025.

With regard to this Application, the GOM has evaluated and determined that the information obtained carries sufficient grounds to initiate an administrative review concerning the imports to the imports of subject merchandise originating or exported from the Applicant pursuant to paragraph 28(1)(a) of the Countervailing and Anti-Dumping Duties Act 1994 and subregulation 34(1) of the Countervailing and Anti-Dumping Duties Regulations 1994.

In accordance with the Countervailing and Anti-Dumping Duties Act 1993 and the Countervailing and Anti-Dumping Duties Regulations 1994, the GOM will initiate the administrative review and the final determination of the administrative review will be made within 180 days from the date of initiation.

The Ministry of International Trade and Industry (MITI) will send a set of questionnaires to interested parties, such as domestic producers, importers and associations. Other interested parties may request for the questionnaires in writing to MITI no later than 13 January 2023. Interested parties may also provide additional supporting evidence to MITI by 28 January 2023. In the event that the interested parties do not provide the necessary information or the information and views are not received in an adequate form within the specified time limit, the GOM may make its final determination based on the available facts.
