PADA menjalankan kuasa yang diberikan oleh subseksyen 28(4) Akta Duti Timbal Balas dan Anti-Lambakan 1993 [*Akta 504*], Kerajaan telah membuat penentuan kajian semula pentadbiran muktamad negatif terhadap pengenaan duti anti-lambakan mengenai import *polyethylene terephthalate* dengan kelikatan lebih daripada 0.70 dL/g yang dikelaskan di bawah Kod Sistem yang Diharmonikan (Kod H.S.) 3907.60 000 dan Tatanama Tarif Berharmonis ASEAN (AHTN) 3907.60.90 00 yang berasal atau diekspor dari Thailand ke dalam Malaysia (“dagangan subjek”).

Sebab bagi penentuan kajian semula pentadbiran muktamad negatif

1. Kerajaan telah membuat penentuan kajian semula pentadbiran muktamad negatif kerana penamatan duti anti-lambakan mengenai import dagangan subjek tidak berkemungkinan menyebabkan lambakan dan kemudaratan kepada industri dalam negeri berterusan atau berulang.

Penamatan duti anti-lambakan

2. Duti anti-lambakan yang dikenakan terhadap import dagangan subjek hendaklah ditamatkan pada 19 Oktober 2016.

COUNTERVAILING AND ANTI-DUMPING DUTIES ACT 1993

NOTICE OF NEGATIVE FINAL ADMINISTRATIVE REVIEW DETERMINATION OF
AN ANTI-DUMPING DUTY WITH REGARD TO THE IMPORTS OF POLYETHYLENE
TEREPHTHALATE ORIGINATING OR EXPORTED FROM THE KINGDOM OF THAILAND

(SR 01/15)

IN exercise of the powers conferred by subsection 28(4) of the Countervailing and Anti-Dumping Duties Act 1993 [*Act 504*], the Government has made a negative final administrative review determination on the imposition of an anti-dumping duty with regard to the imports of polyethylene terephthalate of intrinsic viscosity of more than 0.70 dL/g which is classified under the Harmonized System Code (H.S. Code) 3907.60 000 and ASEAN Harmonized Tariff Nomenclature (AHTN) 3907.60.90 00 originating or exported from the Kingdom of Thailand into Malaysia (“subject merchandise”).

Reasons for negative final administration review determination

1. The Government has made a negative final administration review determination because the termination of the anti-dumping duty with regard to the imports of subject merchandise would be unlikely to lead to a continuation or recurrence of dumping and injury to the domestic industry.

Termination of anti-dumping duties

2. The anti-dumping duty imposed on the imports of subject merchandise shall be terminated on 19 October 2016.
