NOTIFICATION ON ADDITIONAL PORTS IN THE REPUBLIC OF THE UNION OF MYANMAR THAT ARE ABLE TO ACCEPT ATIGA E-FORM D

We are pleased to inform that effective 4 April 2022, there are **six (6) additional ports** in the Republic of the Union of Myanmar (Myanmar), are able to exchange the ATIGA e-Form D. Thus, there will be a total of **eight (8) ports** in Myanmar that can accept the ATIGA e-Form D. The list of ports are as follows:

In this regard, starting from 4 April 2022, **traders** may note that the **ASW consent box in the ePCO system will be automatically ticked and locked** if traders choose **these ports as their port of discharge** to enable the exchange of the ATIGA e-Form D to Myanmar. Exportation to other ports in Myanmar will remain via paper-based ATIGA Form D with electronically affixed signature and seal, until the ports are ready to accept ATIGA e-Form D.
