UTILISATION OF ASEAN TRADE IN GOODS AGREEMENT (ATIGA) E-FORM D DURING THE MOVEMENT CONTROL ORDER PERIOD FROM 18 TO 31 MARCH 2020

The government has imposed a Movement Control Order from 18 to 31 March 2020.

In order to continue facilitating the industry during this period, MITI will start enforcing the utilisation of ATIGA e-Form D for Normal, Back-to-Back and Third Country Invoicing application effective immediately. This means, no manual endorsement of Certificate of Origin will be done for ATIGA Form D. Companies are required to **tick the ASEAN Single Window (ASW) box** in order for your CO to be electronically transmitted via the ASW platform to the importing country as shown below:

ASEAN SINGLE WINDOW (ASW) CONSENT FOR ATIGA

I hereby agree for the data relating to my application as reflected in the ATIGA Form D, to be uploaded onto the ASEAN Single Window and thereafter be exchanged electronically with ready ASEAN Member States.
