WE ARE PLEASED TO INFORM THAT IN PURSUANT OF THE UPGRADING PROTOCOL OF ACFTA, LEADERS FROM THE TEN ASEAN MEMBER STATES OF BRUNEI, CAMBODIA, INDONESIA, LAO PDR, MALAYSIA, MYANMAR, THE PHILIPPINES, SINGAPORE, THAILAND AND VIET NAM, ALONG WITH THE PEOPLE'S REPUBLIC OF CHINA HAVE AGREED TO IMPLEMENT THE REVISED ACFTA RULES OF ORIGIN (ROO) TEXT, REVISED OPERATIONAL CERTIFICATION PROCEDURES (OCP), PRODUCT SPECIFIC RULES (PSR) IN HS 2017 AND REVISED PREFERENTIAL CERTIFICATE OF ORIGIN (PCO FORM E) **STARTING 1 AUGUST 2019, HOWEVER THIS DATE IS SUBJECT TO READINESS OF OTHER MEMBER STATES. EXPORTERS WILL BE NOTIFIED FURTHER SHALL THERE BE ANY CHANGES TO THIS DATE.**

PLEASE BE ADVISED THAT ALL CURRENT COST ANALYSIS (CA) APPROVED UNDER ACFTA SCHEME WILL ONLY BE VALID **UNTIL 31 JULY 2019** AS THE UPGRADING EXERCISE WILL INVOLVES CHANGES IN THE ROO REQUIREMENTS. PLEASE ALSO TAKE NOTE THAT BEGINNING 1 AUGUST 2019, **THE REVISED FORM E IS TO BE PRINTED ON AN ISO A4 WHITE PAPER.**

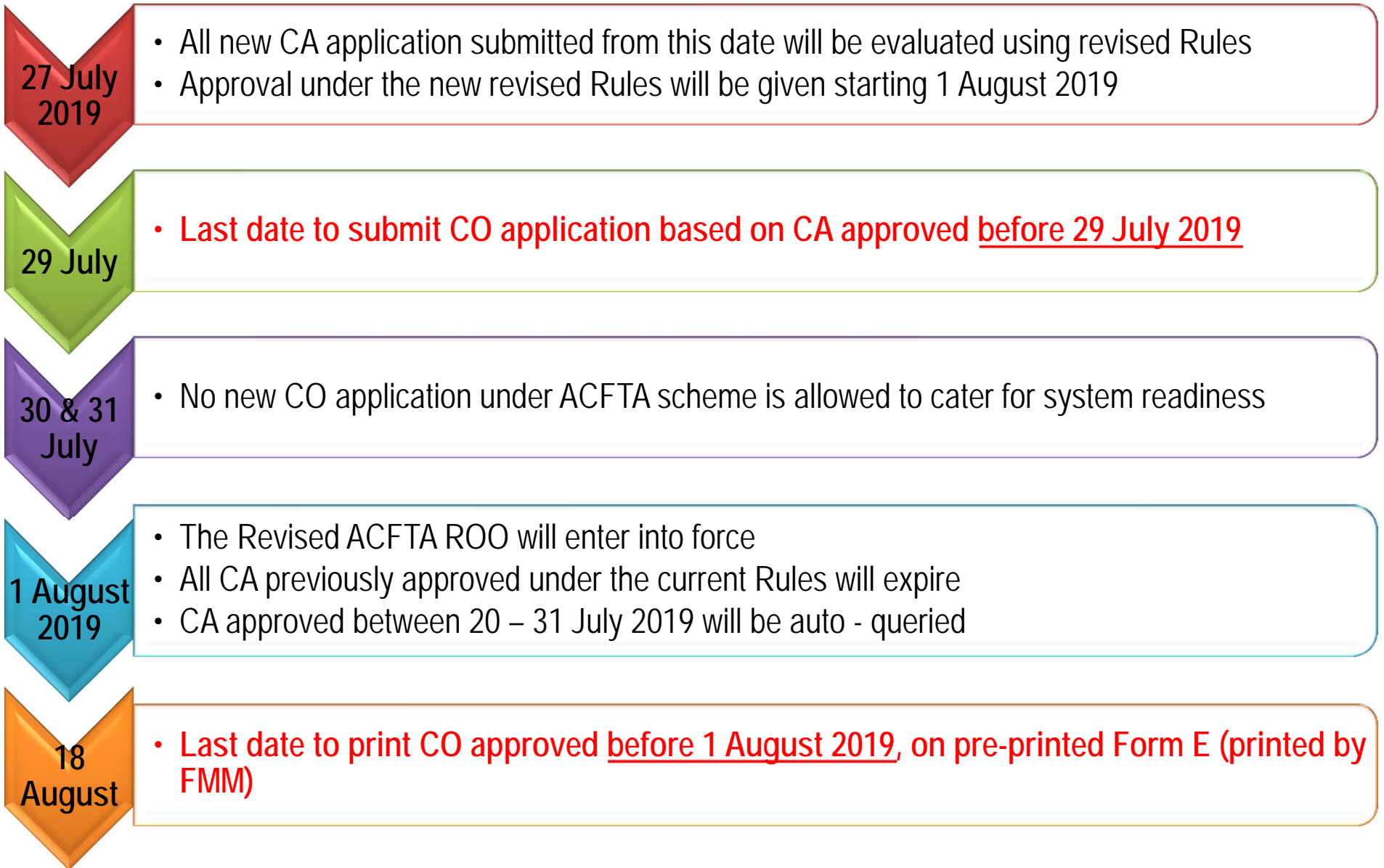
