WE ARE PLEASED TO INFORM THAT STARTING FROM 1 APRIL 2019, BRUNEI IS READY TO JOIN FIVE OTHER PARTICIPATING MEMBER STATES (INDONESIA, MALAYSIA, SINGAPORE, THAILAND, VIETNAM) ON THE ASEAN SINGLE WINDOW PLATFORM IN EXCHANGING PREFERENTIAL CERTIFICATE OF ORIGIN (PCO) UNDER ATIGA SCHEME VIA ONLINE.

EXPORTERS | HOW TO PARTICIPATE:

- ✓ MALAYSIAN EXPORTERS APPLYING PCO FOR EXPORTS TO BRUNEI ARE TO ✓ **THE ASW CONSENT BOX IN E-PCO SYSTEM DURING PCO APPLICATION** IF THEY WISH TO USE E-FORM D. ONCE TICKED AND PCO IS APPROVED BY MITI, INFORMATION OF THE PCO WILL BE ELECTRONICALLY EXCHANGED TO THE BRUNEI RECEIVING AUTHORITY / CUSTOMS. THIS FACILITY WILL BE AVAILABLE FOR EXPORTS FROM MALAYSIA TO BRUNEI BEGINNING **8 APRIL 2019**.

WITH THIS NEW FACILITY IN PLACE, MALAYSIAN EXPORTERS WILL HAVE THE OPTION TO UTILISE EITHER THE MANUAL FORM D OR THE E-FORM D WHEN EXPORTING TO BRUNEI.
