OPENING REMARKS FOR THE ASEAN ECONOMIC COMMUNITY COUNCIL (AECC) SPECIAL SESSION ON ASEAN DEFA

- That said, the issues before us remain complex and will require our strategic guidance and political direction to ensure that negotiations advance in a balanced, pragmatic, and forward-looking manner.
- Excellencies, as we deliberate today, let us remember that DEFA is not only about accelerating digital trade and innovation, but also about ensuring inclusivity and equitable participation, so that our MSMEs, startups, and communities across ASEAN can fully benefit from a trusted, secure, and interoperable digital ecosystem.
- In this spirit, let us be guided by ASEAN's enduring principles of consensus, inclusivity, and mutual benefit, while remaining bold and forward-looking in our ambition to deliver a high-quality, future-ready DEFA that reflects both the dynamism and diversity of our region.
- I am confident that through our collective wisdom and leadership, today's
 discussions will help chart a clear and actionable path towards the timely
 conclusion and signing of DEFA by 2026. This will not only reaffirm
 ASEAN's leadership in shaping the global digital economy, but also
 ensure that our people and businesses remain at the heart of this
 transformation.
