While the global economic landscape may appear fragile, with uncertainties in markets, shifting supply chains and rising protectionist sentiments, ASEAN stands firm united, resilient and forward-looking. ASEAN's strength has always been in our ability to stand together and act collectively, no matter the challenges that come our way. Over the decades, our shared commitment to regional integration, open markets and inclusive growth has safeguarded ASEAN's position as a trusted hub of stability and opportunity in the global economy.
- This spirit of unity and cooperation continues to define us today. Whether through intra-ASEAN collaboration or partnerships with external economies, we have proven that constructive engagement is the key to enduring progress.
- In saying this, I look forward to hearing the progress report on the initiatives undertaken and achievements accomplished under the AEC this year, as reflected in the sequence of agenda items for our discussion. These updates will allow us to take stock of how far we have come, while identifying areas that require renewed focus and collective effort.

- In particular, I look forward to the reporting of Malaysia's 2025 Priority Economic Deliverables (PEDs), which have brought tangible progress to ASEAN's economic integration. If I may share some of the key achievements, are the signing of the upgraded ASEAN Trade in Goods Agreement (ATIGA), the substantial conclusion of the ASEAN Digital Economy Framework Agreement (DEFA) negotiations and the signing of the ASEAN-China FTA 3.0 Upgrade Protocol all three (3) to be announced or signed at the margins of the 47th Summit.
- We also take pride in advancing sustainability and regional resilience through initiatives such as the ASEAN Plan of Action for Energy Cooperation (APAEC) 2035, the Enhanced MoU on the ASEAN Power Grid as well as the Center of Excellence for MSMEs in Green Transition. These successes under Malaysia's Chairmanship this year reaffirm our shared determination to strengthen ASEAN's economic unity, competitiveness, and forwardlooking vision.
- I also look forward to facilitating our discussion on the future direction of the AEC, as we continue our journey towards realising the AEC Post-2025 Vision.
