STRATEGIC TRADE (RESTRICTED END-USERS AND PROHIBITED END-USERS)
(AMENDMENT) ORDER 2016

IN exercise of the powers conferred by section 8 of the Strategic Trade Act 2010 [*Act 708*], the Minister makes the following order:

Citation

1. This order may be cited as the **Strategic Trade (Restricted End-Users and Prohibited End-Users) (Amendment) Order 2016**.

Amendment of Second Schedule

2. The Strategic Trade (Restricted End-Users and Prohibited End-Users) Order 2010 [*P.U. (A) 484/2010*] is amended by substituting for the Second Schedule the following Schedule:
