PADA menjalankan kuasa yang diberikan oleh perenggan 25(4)(a) Akta Duti Timbal Balas dan Anti-Lambakan 1993 [Akta 504] dan peraturan 15 Peraturan-Peraturan Duti Timbal Balas dan Anti-Lambakan 1994 [P.U. (A) 233/1994], Kerajaan telah membuat penentuan muktamad di bawah subseksyen 25(1) bahawa—

- (a) suatu margin lambakan wujud mengenai konkrit prategasan lembar tujuh wayar dan khususnya mengecualikan *Polyethylene Grease Coated PC Strand, Galvanised Steel Wire, Galvanised PC Strand, Indented PC Strand, PC Strand with Spiral Ribs*, tali-tali dan kabel-kabel yang dikelaskan di bawah Nombor Kod Sistem yang Diharmonikan (Kod H.S.) 7312.10.000 (“dagangan subjek”) yang berasal atau dieksport dari Republik Rakyat China; dan
- (b) kemudaratan didapati wujud kerana industri dalam negeri di Malaysia yang mengeluarkan keluaran serupa telah mengalami kemudaratan material disebabkan oleh pengimportan dagangan subjek itu yang berasal atau dieksport dari Republik Rakyat China ke dalam Malaysia.

**Sebab-sebab bagi penentuan**

2. Sebab-sebab bagi penentuan muktamad afirmatif adalah seperti yang berikut:

- (a) harga eksport dagangan subjek yang berasal atau dieksport dari Republik Rakyat China ke dalam Malaysia adalah kurang daripada nilai normalnya;
- (b) industri dalam negeri di Malaysia yang mengeluarkan keluaran serupa telah mengalami kemudaratan material yang boleh dengan semunasabahnya dikaitkan dengan pengimportan dagangan subjek itu yang berasal atau dieksport dari Republik Rakyat China ke dalam Malaysia; dan

- (c) margin lambakan yang didapati wujud melalui kegiatan lambakan oleh pengeluar atau pengeksport dari Republik Rakyat China adalah seperti yang berikut:

4. Sebab bagi duti anti-lambakan di bawah perenggan 3 adalah untuk mencegah berlakunya kemudaratan kepada industri dalam negeri di Malaysia yang mengeluarkan keluaran serupa.

#### **Tempoh pengenaan duti anti-lambakan**

5. Duti anti-lambakan yang dikenakan di bawah perenggan 3 hendaklah terpakai bagi tempoh 5 tahun dari 5 Januari 2014.

COUNTERVAILING AND ANTI-DUMPING DUTIES ACT 1993

NOTICE OF AFFIRMATIVE FINAL DETERMINATION OF AN ANTI-DUMPING DUTY  
INVESTIGATION WITH REGARD TO IMPORTS OF SEVEN WIRES PRE-STRESSED  
CONCRETE STRAND ORIGINATING OR EXPORTED FROM THE PEOPLE'S  
REPUBLIC OF CHINA

IN exercise of the powers conferred by paragraph 25(4)(a) of the Countervailing and Anti-Dumping Duties Act 1993 [Act 504] and regulation 15 of the Countervailing and Anti-Dumping Duties Regulations 1994 [P.U. (A) 233/1994], the Government has made a final determination under subsection 25(1) that—

- (a) a dumping margin exists in respect of the seven wires pre-stressed concrete strand and specifically excluding Polyethylene Grease Coated PC Strand, Galvanised Steel Wire, Galvanised PC Strand, Indented PC Strand, PC Strand with Spiral Ribs, ropes and cables classified under Harmonised System Code (H.S. Code) 7312.10.000 (“subject merchandise”) originating or exported from the People's Republic of China; and
- (b) injury is found to exist because the domestic industry in Malaysia producing the like product has suffered material injury by reason of the importation of the subject merchandise originating or exported from the People's Republic of China into Malaysia.

**Reasons for determination**

2. The reasons for the affirmative final determination are as follows:

- (a) the export price of the subject merchandise originating or exported from the People's Republic of China into Malaysia was less than its normal value;
- (b) the domestic industry in Malaysia producing the like product has suffered material injury that can be reasonably linked to the importation of the subject merchandise originating or exported from the

People's Republic of China into Malaysia; and

- (c) the dumping margin found to exist through the dumping activities by producers or exporters from the People's Republic of China are as follows:

### **Anti-dumping duties**

3. The anti-dumping duties to be imposed shall be as specified in the Schedule.

### **Reason for anti-dumping duties**

4. The reason for the anti-dumping duties under paragraph 3 is to prevent the injury to the domestic industry in Malaysia producing the like product.

### **Period of imposition of anti-dumping duties**

5. The anti-dumping duties imposed under paragraph 3 shall apply for a period of 5 years from 5 January 2014.
